End User Customers**

TERMS & CONDITIONS

1. Description of Promotion:

In this promotion (the “Promotion”), which is governed by these terms and conditions (the “Terms and Conditions”), eligible end user customers of Fluke Electronics Corporation and affiliate companies in respective regions (“Sponsor”), in each case transacting under the Fluke Biomedical brand, may Trade-In (defined below) any Fluke Biomedical Old Product (defined below) or Similar Product (defined below) with a Fluke Health Solutions representative or authorized distributor and receive the discount off the list price for a Fluke Biomedical replacement product (“Replacement Product”) specified in Appendix A (the “Discount”) during the Promotion Period (defined in Section 3 below). Appendix A is incorporated herein by reference and made a part of these Terms and Conditions as if fully set forth herein.

These Terms and Conditions are a binding contract between you and Sponsor regarding the Promotion. Before participating in the Promotion, each customer must review and agree to be bound by these Terms and Conditions. By participating, you represent that you have reviewed the Terms and Conditions, agree to be bound by them, satisfy all the eligibility requirements, and accept the decisions of the Sponsor in all matters relating to the Promotion as final and binding.

For purposes of this Promotion, the terms Trade-In, Old Product, and Similar Product are defined as follows:

- *“Trade-In”* means sending an Old Product or a Similar Product to Sponsor or sending an Old Product or a Similar Product to an authorized Fluke Health Solutions representative or distributor, who will send the Old Product or the Similar Product to Sponsor. Sponsor reserves the right in its sole and absolute discretion to determine whether any Old Product or Similar Product qualifies for Trade-In under the Promotion.
- *“Old Product”* means Fluke Biomedical and RaySafe obsoleted/discontinued products. (For a full list of eligible products visit: <https://www.flukebiomedical.com/support/discontinued-products>). The Old Product must be traded-in for a Replacement Product with a similar application. For example, an old Fluke Biomedical Electrical Safety Analyzer must be traded-in for a replacement Fluke Biomedical Electrical Safety Analyzer.

- *“Similar Product”* means a product from another vendor that has a similar application to a Fluke Biomedical product. To qualify for the Trade-In under the Promotion, the Similar Product must have an application that is similar to the Replacement Product that will replace it. For example, if the customer is trading in an electrical safety analyzer from a brand other than Fluke, the Replacement Product will be a Fluke Biomedical Electrical Safety Analyzer. Sponsor shall determine, in its sole discretion, the appropriate Replacement Product based on the brand, model, and serial number of the Similar Product provided.

2. Eligibility:

This Promotion is open only to eligible participants where the promotion is legally permitted and not restricted or prohibited by law. Participation is available to end user customers located in the European Union (EU), as well as European countries not part of the EU such as the United Kingdom, Norway, Switzerland, and others, provided they are not subject to any trade sanctions or embargoes imposed by the United States government. Eligibility is also extended to select countries in Asia, Africa, the Middle East, North America, and South America.

Participants must be at least 18 years of age or the age permitted by law to participate. The promotion is designed for end users who use the Eligible Products (as defined in Appendix A) for their own business purposes.

Employees, directors and officers of Sponsor, its parent companies, affiliated companies, subsidiaries, distributors, representatives, and those persons' immediate families (parents, siblings, children and spouse) and persons living in the same household (whether related or not) are not eligible to participate in the Promotion. Further, no employees, officers, directors, representatives or agents of Sponsor's distributors or competing tool manufacturers are eligible to participate in the Promotion.

3. Promotion Period:

The promotion period starts at 12:00 AM US Pacific Time on October 7, 2024 and ends at 11:59 PM US Pacific Time on December 20, 2024 (the "Promotion Period"). US Pacific Time shall control for all purposes of the Promotion. Sponsor's computer shall be the official time-keeping device for the Promotion.

4. Other Restrictions and Limitations of the Promotion:

The customer or authorized distributor will receive the Discount off the manufacturer's regional list price for the Replacement Product from a Fluke Health Solutions representative during the Promotion Period. Authorized distributors should pass the benefit of the promotional offer to the end customer. Authorized distributors are free to provide additional discounts to end customers.

Each Old Product or Similar Product traded-in will be eligible for one Discount on its respective Replacement Product. *In no event will an Old Product or Similar Product qualify for more than one application of the Discount.*

1. Trade-In Discount Structure. The Program offers a tiered discount structure based on the number of products participants trade in. For each eligible product that a participant sends in for trade-in the participant will receive a discount on the purchase of one new product from the Sponsor. Specifically, a one-to-one trade-in will result in a discount on one new product. Similarly, if a participant trades in five products, they are eligible for a discount on five Discounted Products. The discount applied to each Discounted Product will correspond to the number of Traded Products sent in. For "Old Product" the discount is structured as follows (1 trade-in = 10%, 2 trade-ins = 15%, and 3 or more trade-ins = 20%). For "Similar Product" the discount structure is 20% for any number of units traded in.

The discount cannot be applied retroactively and must be used at the time of the qualifying transaction. Discounts are non-transferable and cannot be exchanged for cash or other forms of credit. All trade-ins are subject to verification and approval by the Sponsor in its sole discretion. Additional terms and conditions may apply.

The Sponsor reserves the right to modify, alter, or cancel the tiered discount structure at any time without prior notice, subject to applicable law. Changes to the trade-in discount structure will not affect trade-ins that have already been accepted and processed by the Sponsor prior to the date of any such change.

The Promotion is only available as a discount to the list prices of the Replacement Products listed on Appendix A. The Discount available under the Promotion cannot be used in conjunction with any end customer contract or special pricing, or be combined with any other discounts, coupons, credits, rebates or other special offers from the Sponsor. The Discount available under the Promotion also cannot be transferred or otherwise redeemed for alternative products, services or credits except as expressly authorized in these Promotion Terms and Conditions.

5. Instructions on How to Participate in the Promotion:

To complete your trade-in of an Eligible product, follow the instructions below:

- a. Send an email to your Fluke Health Solutions sales representative or authorized distributor with the following information:
 - i. Brand, model number, and serial number of each unit to trade;
 - ii. Product(s) of interest to buy;
 - iii. Contact info: name, company, email, and phone
 - iv. Customer will receive a call back and/or email with a quote and further information on next steps which includes the following and any additional information from Sponsor or authorized distributor
- b. Purchase order should include appropriate promo code:
 - i. Old Product:
 1. **For 1 unit: FBC_FBC_GLB_2024_FHS_Trade-in-OP-10**
 2. **For 2 units: FBC_FBC_GLB_2024_FHS_Trade-in-OP-15**
 3. **For 3 or more: FBC_FBC_GLB_2024_FHS_Trade-in-OP-20**
 - ii. Similar Product:
 1. **FBC_FBC_GLB_2024_FHS_Trade-in-Promo-SP-20**
- c. When Sponsor receives the order, the Sponsor may issue a Return Material Authorization (“RMA”) for the return of your trade-in product, or authorized distributor will provide information for you to send product to them.
- d. If required, you must return your trade-in product within six weeks following dispatch of the new product in exchange for the trade-in discount. If you fail to do so, you will be charged the discount percentage or amount that the Sponsor has provided to you under the Program. To return the trade-in product, write the RMA number on the shipping carton and ship to the address specified in the RMA or, if nothing is specified there, to your local Fluke Health Solutions sales representative or authorized distributor.

The decision whether a trade-in product qualifies as an Eligible Product under the Program is at the sole and absolute discretion of Sponsor. The trade-in product does not have to be in working condition. All instruments returned as a trade-in under this Program become the property of Sponsor. All costs, taxes, customs duties, fees and expenses associated with a customer’s participation in the Program, including shipping and handling of trade-in products, are the responsibility of the customer. Any taxes/fees are the responsibility of the recipient.

6. Disclaimer:

Sponsor and each of its parent companies, subsidiaries, and affiliates, and each of their respective directors, officers, professional advisors, distributors, representatives, employees and agents (collectively, the “Released Parties”) will not be responsible or have any liability for: (a) any late, lost, misrouted, garbled or distorted or damaged communications, transmissions or redemption requests related to the Promotion; (b) telephone, electronic, hardware, software,

network, Internet, or other computer- or communications-related malfunctions or failures related to the Promotion; (c) any Promotion disruptions, injuries, losses or damages caused by events beyond the control of Sponsor or by non-authorized human or other intervention; or (d) any printing or typographical errors in any materials associated with the Promotion.

All discounts provided under the Promotion are intended to comply with the federal Anti-Kickback Statute, 42 U.S.C. § 1320a-7b(b). To the extent required by 42 C.F.R. Section 1001.952(h) (the Anti-Kickback Statute discount safe harbor regulations) or other applicable laws and regulations, the customer must fully and accurately reflect in cost reports or other submissions to federal healthcare programs all discounts provided under the Promotion, and upon request by the Secretary of the U.S. Department of Health and Human Services or a state agency, must make available information provided to the customer by Sponsor concerning the discounts.

7. Release of Liability and Indemnification:

Except where otherwise prohibited by law, by participating in the Promotion, the customer releases and agrees to indemnify and hold harmless each Released Party from any liability, obligation, injury, claim, suit, action, cost, expense, loss or damage of any kind, including any tax liability or loss of opportunity, whether direct, indirect, special, incidental or consequential, that may be imposed on, asserted against or incurred by such Released Party that arise out of or relate in any way to the Promotion and the offers made hereunder, including, but not limited to, the following: (a) any technical difficulties or equipment malfunction (whether or not under Sponsor's control); (b) any theft, unauthorized access or third party interference; (c) any redemption request that is late, lost, altered, damaged or misdirected (whether or not after their receipt by Sponsor, and whether or not in Sponsor's control); (d) any damages due to the operation of the postal service; (e) any variation in product value to that stated in these Promotion Terms and Conditions; (f) any tax liability incurred by participant; or (g) use or misuse of the products offered under the Promotion.

8. Miscellaneous:

The Promotion and these Terms and Conditions will be governed, construed and interpreted under the laws of the Sponsor entity authorized to transact in the country or territory where the customer is located without applying any conflicts or choice of law provisions under such law that might refer the construction or interpretation of any term hereof to the laws of any other territory or jurisdiction and any action brought regarding the Promotion and these Terms and Conditions may only be brought in the national, state or federal courts of such country or territory, and each party to such action expressly consents to jurisdiction of those courts. If any provision of these Terms and Conditions is held illegal or unenforceable in a judicial proceeding, such provision shall be severed and shall be inoperative, and, provided that the fundamental terms and conditions of these Terms and Conditions remain legal and enforceable, the remainder of these Terms and Conditions shall remain operative and binding.

The customer is bound by these Terms and Conditions and by the decisions of Sponsor, which are final and binding in all respects. To the extent permitted by law, Sponsor reserves the right to change these Terms and Conditions at any time, including, but not limited to, adding, removing and modifying products or any services on the product list, in its sole and absolute discretion, and to suspend or cancel the Promotion or any customer's participation in the Promotion should computer viruses, unauthorized human intervention or other causes beyond Sponsor's control affect the administration, security or conduct of the Promotion, Sponsor otherwise becomes (as determined in its sole and absolute discretion) incapable of conducting the Promotion as planned, or for any other reason determined by Sponsor to be appropriate in its sole and absolute discretion.

Customer represents and warrants that they have the legal right to participate in the Promotion and Trade-In the Old Product or the Similar Product, that the Old Product and/or Similar Product are not counterfeit or stolen, and that customer's submission of them to Sponsor complies with these Terms and Conditions.

These Terms and Conditions constitute the entire agreement governing the Promotion, and no other agreement, verbal or otherwise, shall be binding regarding the Promotion unless it is in writing and signed by Sponsor. In case of any conflict or inconsistency between any other document relating to the Promotion and these Terms and Conditions, these Terms and Conditions shall control. To the maximum extent provided by law, no waiver of any provision of these Terms and Conditions will be implied from any course of dealings between the customer and Sponsor or from any failure by the customer or Sponsor to assert its rights hereunder on any occasion or a series of occasions.

Any customer who violates these Terms and Conditions, violates any law, rule or regulation in connection with participation in the Promotion, tampers with the operation of the Promotion, or engages in any conduct that is detrimental or unfair to Sponsor, the Promotion or any other participant (in each case as determined in Sponsor’s sole and absolute discretion) is subject to disqualification from participation in the Promotion and all other rights and remedies available under the law.
