### About CAFS

As the risk of fraud increases, professionals and organizations must find ways to stop criminals in their tracks. The Certified Anti-Fraud Specialist (CAFS) Certification provides a comprehensive and balanced learning framework for professionals working in fraud-related roles.

CAFS uniquely addresses the challenges faced by banks and other financial institutions today. From authorized push payments to account takeovers, our program reviews both well-known and emerging fraud typologies.

Completing this specialist-level certification will give professionals the knowledge necessary to detect and investigate fraud, and implement effective controls to minimize losses and ensure the protection of customer assets.

### CAFS Course Content

The CAFS program covers key topics across the spectrum of fraud prevention, detection, and response, including fraud analytics, technology, and completing successful fraud investigations. CAFS is structured in a modular format, comprising five distinct modules (also called certificate courses):

2. Fraud Detection and Analytics

5. Fraud Case Studies

To earn CAFS, candidates must complete all five modules as part of their learning program and pass the proctored CAFS exam. Each certificate course can also be purchased separately.

## The CAFS Exam

The CAFS exam is 175 minutes long and comprises 100 questions in total. There are both multiple choice (select one answer) and multiple select questions (select all answers that fit).

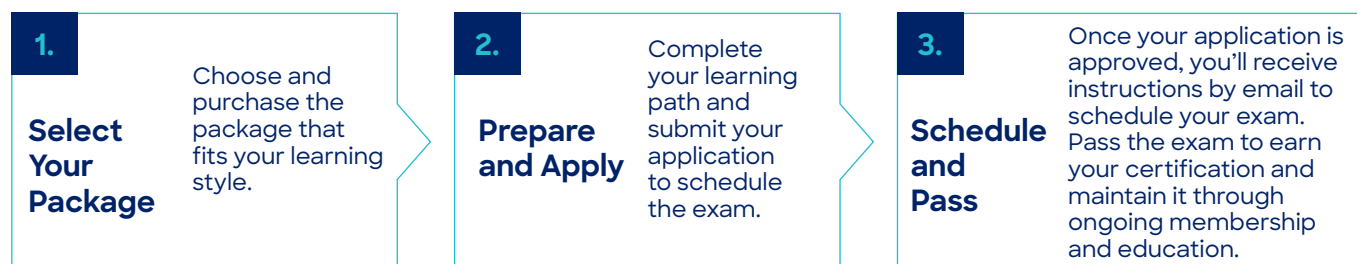
Candidates receive their exam results immediately (pass or fail) at the conclusion of the test.

## Candidate Requirements

Candidates must have an active ACAMS membership and present evidence of 40 eligibility credits to be eligible to take the CAFS exam. These credits can be obtained through education, professional experience, and relevant training.

The training components of the CAFS program are worth 17 ACAMS credits and the Virtual Classroom Series provides an additional 12 ACAMS credits.
