
Product Makeup, Mix & Management

- 7,165+ trees
- 3,945 barrels of oil and associated energy costs and resources
- 11.2 million gallons of water
- 6.9 million kW-hours
- And we diverted 8.6 million pounds of waste from landfills

Company-wide reclaimed plastic from our production in 2024 has saved or preserved more than:

- 769 million kW-hours of electricity
- 104 million gallons of water
- 1.4 million barrels of oil
- 2.75 million cubic yards of landfill avoidance




Corporate Overview




Inteplast Group - Lolita, TX 2024 Landfill vs. Avoidance

ESG

ESG refers to the environmental, social, and governance factors that are commonly used to holistically measure and analyze a company's sustainability efforts.

Environmental

The environmental pillar of ESG encompasses many core sustainability priorities, including climate impact, biodiversity, and carbon footprint (CFP).

To strengthen our strategy in reducing CFP, Inteplast collaborates with leading sustainability experts. Accurately measuring CFP requires thorough analysis and considerable time, but every effort devoted to uncovering improvement opportunities is an investment in long-term progress. The Group is actively compiling CFP data across all reporting scopes to better target greenhouse gas reduction.

Beyond carbon management, Inteplast works with organizations such as the Lavaca-Navidad River Authority (LNRA) Clean Rivers Program to support local biodiversity and with initiatives like Operation Clean Sweep (OCS) to advance sustainability on a global level.

Social

Inteplast Group supports its employees by offering competitive compensation packages and benefits. In addition, the company and its business units actively identify organizations and causes that reflect our core values. Through the Inteplast Cares program in 2024, plant managers at more than 50 locations have selected a wide range of agencies and groups to receive impactful contributions, reinforcing our commitment to community engagement and social responsibility.

Governance

Inteplast Group upholds internationally recognized standards for human rights, fair employment, environmental responsibility, and ethical business practices. These commitments reinforce a culture of integrity and transparency across all operations, from the production floor to sales meetings. In addition, we maintain fiscally responsible practices, including the timely closing of financial reports on the first day of each month, ensuring the company's economic trajectory remains clear, verifiable, and accessible to employees and stakeholders alike.



Operation Clean Sweep: An Industry Necessity

Operation Clean Sweep® (OCS) is an international program designed to prevent resin pellets, flakes, and powder loss along with keeping pellets out of marine environments. Every segment of the plastics industry has a responsibility — including resin producers, transporters, bulk terminal operators, plastics processors and recyclers — to implement good housekeeping and containment practices. Spilled pellets, flakes, and powder can make their way into local waters and eventually end up in our oceans where they become a threat to sea life and a source of contamination for other water-related systems. Reducing such loss can only be achieved with our collective help.

Founded by Plastic Industry Association in 1991, OCS is managed in partnership with the American Chemistry Council Plastics Division, as well as 22 other associations around the world.

Operation Clean Sweep has strengthened its global stance on resin control. In fact, Operation Clean Sweep supports companies in their goal towards achieving zero plastic resin loss in operations. Inteplast Group had no releases this year.

Inteplast Group is registered with OCS Blue which represents the highest level of membership and commitment to controlling pellet pollution.

As an OCS Blue member, we've committed to the following. Each of our Group's locations are slated to diligently follow through as indicated:

- Assign an OCS coordinator for the site (OCS provides a best practices document that a facility's resin expert can reference)
- Educate employees about resin control at time of hire
- Plan and deliver briefings about resin handling

- Display the OCS plaque, certificate, and posters
- Routinely address housekeeping procedures and refer to OCS checklists and tools
- Hold an OCS event at the plant
- · Conduct internal audits
- · Participate in third party audits






Sustainability for the Future

Measurable Goals

As part of our commitment to sustainability, Inteplast is dedicated to achieving a 10% annual reduction in waste sent to landfills through our Zero Waste Program.

By analyzing our monthly reports, including our reclaim numbers, we can track our progress in ESG (Environmental, Social, and Governance) initiatives. This insight allows us to effectively plan and set goals for sustainable developments.







Rideshare Program

In the pursuit of sustainability, Inteplast Group partnered with Enterprise in its vanpool program, Commute with Enterprise. Not only does this rideshare program contribute to reducing our carbon footprint, it also provides a direct benefit to our employees. Employees save an estimated \$18,540 in commuter costs and reduce approximately 28,320 miles on their personal vehicles every year.

By the end of 2024, Commute with Enterprise reduced the number of vehicles driven to work each day by 91. This equates to a gas emission reduction of 537 tons of CO2 per year on average.




