RIGID CORE SPC LIFETIME / 10 YEAR WARRANTY





RESIDENTIAL LIMITED WARRANTY

RW Supply+Design (RW+) warrants its Rigid-Core Collection (RCC) products, in their original manufactured condition, to be free from defects in construction: lamination, milling, dimension, and assembly. RW+ does allow for an industry norm of up to 5% of the product to be non-conforming. RW+ warrants that the Rigid-Core Collection will not wear through or lose the original pattern or color due to normal wear. The Rigid-Core Collection will remain free from structural and finish defects for the duration of the warranty period stated for this application provided the product is installed and maintained in accordance with the Rigid-Core Collection Installation Instructions and maintained in a controlled environment as outlined in the installation instructions. This warranty is extended to the original purchaser of the goods and is not transferable.

LIGHT COMMERCIAL LIMITED WARRANTY

RW+ warrants its Rigid-Core Collection products, in their original manufactured condition, to be free from defects in construction: lamination, milling, dimension, and assembly. RW+ warrants that the Rigid-Core Collection will not wear through or lose the original pattern or color due to normal wear. The Rigid-Core Collection will remain free from structural and finish defects for the duration of the warranty period stated for this application provided it is installed and maintained in accordance with the Rigid-Core Collection Installation Instructions. This is also true when this flooring is maintained in a controlled environment as outlined in the installation instructions, and the floor is not subjected to water leaks, floods, or heavy commercial maintenance procedures (using buffers and floor scrubbers). Due to the nature of this application, this light commercial limited warranty is applicable to installations over concrete only. This warranty is extended to the original purchaser of the goods and is not transferable.

Light Commercial Definition

Light commercial installations will not be subject to heavy commercial objects such as retail fixtures or other machinery such as auto-scrubbers or pallet jacks, placed on or dragged across the floor. Examples of light commercial applications are doctor's offices, business conference rooms, CPA, and attorney's office, etc. Heavy traffic locations such as restaurants and big box retail are not considered light commercial applications and are not covered by this warranty. The same exclusions pertaining to the residential warranty apply to the light commercial warranty.

WATERPROOF WARRANTY

Rigid-Core Collection (RCC) planks are waterproof. However, moisture can pass through improperly seated seams, around expansion gaps, and room perimeters. During the warranty period, RW+ warrants that your floor will not warp, curl, crack, or cup due to:

- Cleaning procedures recommended in the Multi- Length Collection Installation Instructions and
- Incidental spills typical of a residential setting





It is important that subfloor moisture be mitigated prior to flooring installation. This rigid core vinyl plank product with integrated pad has a structure that can be adversely affected by constant exposure to elevated subfloor moisture. For this reason and to ensure a successful finished product, an impermeable moisture barrier is required when installing over concrete subfloors as detailed by RCC Installation Instructions. Wood subfloors should have proper moisture mitigation installed underneath them per RCC Installation Instructions.

The installed flooring is not intended to be a moisture barrier, though it can trap moisture underneath it. This warranty excludes any damage caused to the subfloor and dwelling due to moisture. Moisture trapped underneath RCC can create conditions that adversely affect flooring and subflooring.

Fixtures that surround the floor such as walls, trim moldings, subfloors, and other flooring types, are not considered waterproof. Excessive and unmitigated moisture in contact with or being trapped between Rigid-Core Collection planks and these fixtures can cause mold, mildew, or other damage. This warranty excludes any damage from mold, flooding, leaky plumbing, appliances, or any moisture from exterior sources. Wipe up all standing liquids and moisture immediately.

WARRANTY EXCLUSIONS

RW+ warranties do not cover indentations, scratches, defects or damage caused by the failure to follow all the Rigid-Core Collection Installation Instructions. Responsibility for inspection and approval of planks falls to the consumer and installer prior to installation. The installer is the final inspector of the product because installation is acceptance of the product. RW+ is not responsible for labor costs associated with the repair or replacement of visually or structurally defective planks after the floor is installed. Prior to installation, the installer should make certain that the subfloor is thoroughly inspected ensuring it is flat, clean, dry, and structurally sound according to the Rigid-Core Collection Installation Instructions.

RW+ warranties do not cover normal wear and tear, indentations, scratches, defects, or damage caused by improper maintenance, insufficient protection, misuse, or improper alterations of the original manufactured product.

RW+ warranties do not cover damage caused by the use of oil soaps, liquid or paste wax products, furniture oils and polishes, acrylic products, or other household cleaners that are not recommended maintenance products.

RW+ warranties do not cover structural and finish damage from heavy medical equipment such as wheelchairs, chair lifts, or medical beds.

RW+ warranties exclude non-factory applied finishing.

RW+ warranties do not cover indentations, scratches, defects, or damages caused by negligence or abuse including, but not limited to water, insects, pets, spiked (or damaged heel) shoes, vacuums, furniture, appliances, casters, fallen or dropped objects, or construction traffic. Failure to take proper precautions to protect furniture legs and feet with protective felt pads and properly functioning casters or failure to protect floors during the construction process or when moving heavy objects, or during times of heavy traffic that result in any damages stated above are not covered by these warranties.

RW+ warranties do not cover defects and damage caused by natural disasters or disasters of human origin including but not limited to, leaking or broken plumbing, fire, flood, earthquake, or standing water during or after construction.

RW+ warranties do not cover discoloration due to direct sunlight or extreme heat. Most home products will discolor due to a combination of heat and sunlight.

No warranties apply to any product or products designated as seconds, off-goods, or goods sold in "as is" condition.



RW+ warranties do not cover squeaking, creaking, popping, or other noises in flooring as these are the result of installation, jobsite, and/or environmental causes.

The following items are not covered under the warranty:

- Flooring installed in a method other than provided for in the Rigid-Core Collection Installation Instructions.
- Damage caused by normal wear and tear, negligence, accidents, misuse, or abuse.
- Damage caused by vacuum cleaners, wet mopping, or steam mops.
- Damage caused by appliances, furniture, and casters.
- Damage caused by cutting from sharp objects.
- Damage caused by flooding, fire, and other natural disasters and acts of God.
- Reduction in gloss, scuffs, scratches, or indentation due to sand, rocks, or other abrasives, including pets, insects, construction traffic, or failure to maintain the floor as required by the Multi-Length Installation Instructions
- Color, shade, sheen or texture variations between samples or replacement flooring and the actual material.
- Color variations between flooring and/or samples and other flooring or wood products, which you wish to match (e.g., cabinets, stair railings, trim, etc.).
- Changes in color due to exposure to sunlight and age.
- Deficiencies related to subfloor/floor assemblies, subfloor preparation materials, and fasteners including, but not limited to, uneven subfloor surfaces, floor deflection, or voids in the subfloor.
- Noises, squeaks, etc.
- Natural expansion and contraction resulting in damage or separation between boards or damage caused by excessive heat or extreme cold.
- Flooring separation due to an uneven or flexible subfloor.
- Products designated "off-goods" or products that are sold "AS IS."
- Commercial installations of residential products.
- Flooring installed outside or on the exterior of a building.
- Construction or installation-related damage.
- Floor damage, finish damage, or adhesive breakdown caused by subfloor moisture or water damage, including but not limited to, broken or leaking water pipes, flooding, wet-mopping spills, or weather conditions.

NO OTHER WARRANTIES

This limited warranty is the only warranty given by RW+ as pertaining to the Residential Limited Warranty, Light Commercial Warranty, and Waterproof Warranty, and no other warranties or guarantees of merchantability of any kind have been made with respect to RW+ or Rigid-Core Collection products. No oral agreement or statement from RW+, or any of its representatives may alter or amend this warranty.

NO WARRANTY OF FITNESS EXISTS BEYOND THE GENERAL WRITTEN DESCRIPTION OF THE PRODUCT PURCHASED.

Some laws do not allow limitations on certain implied warranties. This warranty gives specific legal rights, and there may be other rights which vary from state to state.

YOU AND YOUR INSTALLER ARE RESPONSIBLE TO INSPECT FLOORING PRIOR TO INSTALLATION. WE ACCEPT NO RESPONSIBILITY FOR LIABILITIES, CLAIMS OR EXPENSES, INCLUDING LABOR COSTS, WHERE FLOORING WITH VISIBLE OR MEASURABLE DEFECTS HAS BEEN INSTALLED. ALL FLOORING CAN CONTAIN UP TO AN INDUSTRY NORM OF 5% NON-CONFORMING PRODUCT.

HOW TO MAKE A CLAIM

In the unlikely event that any portion of your floor should fail or be defective, with respect to any of the provisions of this warranty, RW Supply+Design, at its sole discretion, to the original end-user, may repair or replace such portion with the same product or another product of equal value. This provision does not include labor costs, relocation or living expenses, removal or installation of new flooring or the removal or replacement of cabinets, furniture, and other fixtures.

To file a claim, the original purchaser must initiate a claim request by filling out our on-line form at: <u>https://rwsupply.com/claims</u> or <u>https://portercraft.com/claims</u>. Claims must also be filed within the warranty coverage period and information verifying the date of purchase will be requested. RW+ reserves the right to have a designated representative inspect the floors and remove samples for technical analysis.

This writing is the complete and exclusive statement of the warranty and is in lieu of all other express and/or statutory warranties. RW+ assumes no liability for incidental or consequential damages. However, some states do not allow this exclusion and may not apply in all cases. This warranty gives you specific legal rights that may vary from state to state.
